Jim Juneau is a Dallas, TX board-certified personal injury trial lawyer who specializes in complex cases involving products liability, catastrophic injury and wrongful death. Over his 24-year legal career, he has developed a special expertise in fire apparatus and firefighting equipment, and has handled many serious injury and death cases involving fire apparatus and firefighting equipment.

Juneau has written many safety articles and has been interviewed on numerous radio and TV programs discussing fire safety issues. "Charleston Sofa Super Store Fire Analysis"



J. Gordon Routley

J. Gordon Routley will present a detailed analysis of the Sofa Super Store Fire in Charleston, SC, that resulted in nine firefighter fatalities. The program will identify the specific problems that were encountered and recommend actions to prevent future occurrences of a similar nature.

J. Gordon Routley is a fire protection engineer who provides consulting services to fire departments and fire service related organizations in the United States and Canada. He previously served as Fire Chief in Shreveport, Louisiana; Assistant to the Fire Chief in Phoenix, Arizona; and Fire Department Safety Officer in Prince George's County, Maryland. He is currently the Technical Advisor to the Fire Chief in Montreal, Canada. He was the project leader for the City of Charleston Fire Assessment and Review Team and has conducted more than 30 firefighter fatality investigations. In addition, he works with the National Fallen Firefighters Foundation on the Firefighter Life Safety Initiatives Project and is a member of the Board of Directors of the Safety, Health and Survival Section of the International Association of Fire Chiefs.

"Firefighters and Fire Officers: Scared Straight!"

Chief Billy Goldfeder will present to the attendees, through video, audio and "wake up" lecture, an in-depth review of specific timely fireground events and most specifically, the lessons learned so that these incidents (and those involved) don't ever become forgotten. This very personal, high energy class provides the attendees an excellent opportunity to apply the lessons learned to their own departments and themselves, when returning home, potentially avoiding "history tragically repeating itself."

Chief Billy Goldfeder, EFO, a firefighter since 1973, serves as Deputy Fire Chief of the Loveland-Symmes Fire Department in Ohio. A Chief Officer since 1982, he has served as a fire chief in Ohio, Virginia and Florida. Goldfeder also served as a Public Protection representative covering southern New York, for I.S.O. as well as a company officer, starting with the Manhasset-Lakeville Fire Department, in Long Island. A 1993 graduate of the National Fire Academy's Executive Fire Officer Program, he is the former Chair of the International Association of Fire Chiefs VCOS Section. He serves as an Associate/Contributing Editor for Fire Engineering, Fire Rescue, Firehouse as well as www.firehouse.com and is a member of the Fireman's Fund Heritage Program Advisory Board.

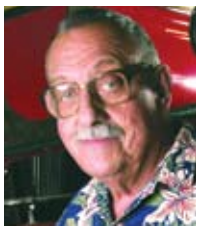
